- WHEREAS, The Iloilo Science and Technology University Miagao Campus, advertised the Invitation to Bid for the **Procurement of Science Laboratory Equipment (Upgrading of Laboratory Equipment)** through Fund 101 (Capital Outlay) with an ABC of **Php 180,800.00** on PhilGEPS, ISAT U Miagao Campus Website, BAC Bulletin Board and BAC Facebook Page;
