RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF ELECTRICAL SUPPLIES TO WINTERFIELD MARKETING

- WHEREAS, The Iloilo Science and Technology University Miagao Campus, advertised the Invitation to Bid for the **Procurement of Electrical Supplies** through Fund 164 with an ABC of **Php 257,188.00** on PhilGEPS, ISAT U Miagao Campus Website, BAC Bulletin Board and BAC Facebook Page;
- WHEREAS, In response to the said advertisement, three (3) prospective bidders purchased the bid documents, and submitted their respective proposals;
- WHEREAS, Only two (2) bidders were declared "passing" in Technical and Financial Components; during the Opening of Bids on March 6, 2023 at 10:00 A.M.;
- WHEREAS, The bidding yielded the following result:

- WHEREAS, A detailed bid evaluation and post-qualification in pursuant to Section 32.2 of 2016 Revised IRR of R.A. 9184 was conducted by the members of the BAC and TWG to verify, validate, and determine the accuracy of the legal, technical, and financial documents submitted by **WINTERFIELD MARKETING** in order to ensure that the bidder passed all the requirements and conditions specified in the Bidding Document; and
- WHEREAS, In the Post Qualification Report, submitted by the Technical Working Group (TWG), **WINTERFIELD MARKETING** was found to be responsive;
- NOW, THEREFORE, The Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare **WINTERFIELD MARKETING** as the **Lowest Calculated Responsive Bid (LCRB)** for the Procurement of Electrical Supplies; and
