BAC RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF OFFICE AND JANITORIAL SUPPLIES (FUND 101)

RESOLUTION NO. 2023-018

- WHEREAS, The Iloilo Science and Technology University Miagao Campus, posted the Invitation to Bid (ITB) for the **Procurement of Office and Janitorial Supplies (Fund 101)** on the website of PhilGEPS, ISAT U Miagao Campus Website, BAC Bulletin Board and BAC Facebook Page with an Approved Budget of Contract (ABC) of **Five Hundred Three Thousand One Hundred Ninety Two Pesos (Php 503,192.00)**;
- WHEREAS, On July 27, 2023, a Pre-Bid Conference was held and attended by five (5) prospective bidders;
- WHEREAS, In response to the said posting, three (3) prospective bidders purchased the bid documents, but only one (1) submitted the respective proposal;
- WHEREAS, The pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;
- WHEREAS, Only one (1) bidder was declared “passing” in Technical and Financial Components; during the Opening of Bids held on August 8, 2023 at 9:30 A.M.;
- WHEREAS, The bidding yielded the following result:

- WHEREAS, A detailed bid evaluation and post-qualification in pursuant to Section 32.2 of 2016 Revised IRR of R.A. 9184 was conducted by the members of the BAC and TWG to verify, validate, and determine the accuracy of the legal, technical, and financial documents submitted by **NEWTOWN MERCHANDISING, INC.** in order to ensure that the bidder passed all the requirements and conditions specified in the Bidding Document; and
- WHEREAS, In the Post Qualification result conducted by the Technical Working Group (TWG), **NEWTOWN MERCHANDISING, INC.** was found to be responsive;



NOW, THEREFORE, The Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare **NEWTOWN MERCHANDISING, INC.** as the **Lowest Calculated Responsive Bid (LCRB)** for the Procurement of Office and Janitorial (Fund 101); and

RESOLVED FURTHER, To recommend to the University President of Iloilo Science and Technology University, the Head of the Procuring Entity the approval to award the Contract for the Procurement of Office and Janitorial Supplies (Fund 101) to **NEWTOWN MERCHANDISING, INC.**
