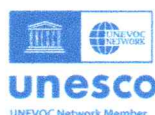
BAC RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF ICT SUPPLIES, ACCESSORIES AND EQUIPMENT (FUND 164)

RESOLUTION NO. 2023-020

- WHEREAS, The Iloilo Science and Technology University Miagao Campus, posted the Invitation to Bid (ITB) for the **Procurement of ICT Supplies, Accessories and Equipment (Fund 164)** on the website of PhilGEPS, ISAT U Miagao Campus Website, BAC Bulletin Board and BAC Facebook Page with an Approved Budget of Contract (ABC) of **Two Million Seven Hundred Eleven Thousand Six Hundred Five Pesos (Php 2,711,605.00)**;
- WHEREAS, On August 17, 2023, a Pre-Bid Conference was held and attended by four (4) prospective bidders;
- WHEREAS, In response to the said posting, three (3) prospective bidders purchased the bid documents, and submitted their respective proposals;
- WHEREAS, The pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184;
- WHEREAS, Three (3) bidders was declared "passing" in Technical and Financial Components; during the Opening of Bids held on September 1, 2023 at 1:30 PM.;
- WHEREAS, The bidding yielded the following result:

- WHEREAS, A detailed bid evaluation in pursuant to Section 32.2 of 2016 Revised IRR of R.A. 9184 was conducted by the members of the BAC and TWG to verify, validate, and determine the accuracy of the legal, technical, and financial documents submitted by **OXORD COMPUTER SOLUTIONS & REPAIR CENTER** in order to ensure that the bidder passed all the requirements and conditions specified in the Bidding Document;
- WHEREAS, In the bid evaluation result, **OXORD COMPUTER SOLUTIONS & REPAIR CENTER** was found to be non-responsive/non-compliant, since did not include the required/ original Technical Specifications as stated in Bidding Documents;



WHEREAS, A Notice of Post Disqualification dated September 5, 2023 was sent and was duly received by Riza D. Brillantes, Authorized Representative of **OXORD COMPUTER SOLUTIONS & REPAIR CENTER** on the same date;

WHEREAS, The Bids and Awards Committee haven't received a Motion for Reconsideration from the said bidder, within three (3) calendar days, upon their receipt of the said notice as the prescribed period for the Motion;

WHEREAS, The Bids and Awards Committee, unanimously decided to proceed with the evaluation and post-qualification of the 2nd Lowest Bidder, Microgenesis Software, Inc.;

WHEREAS, A detailed bid evaluation and post-qualification in pursuant to Section 32.2 of 2016 Revised IRR of R.A. 9184 was conducted by the members of the BAC and TWG to verify, validate, and determine the accuracy of the legal, technical, and financial documents submitted by **MICROGENESIS SOFTWARE, INC.** in order to ensure that the bidder passed all the requirements and conditions specified in the Bidding Document;

WHEREAS, In the Post Qualification result conducted by the Technical Working Group (TWG), **MICROGENESIS SOFTWARE, INC.** was found to be responsive;

NOW, THEREFORE, The Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to declare **MICROGENESIS SOFTWARE, INC.** as the **Lowest Calculated Responsive Bid (LCRB)** for the Procurement of ICT Supplies, Accessories and Equipment (Fund 164); and

RESOLVED FURTHER, To recommend to the University President of Iloilo Science and Technology University, the Head of the Procuring Entity the approval to award the Contract for the Procurement of ICT Supplies, Accessories and Equipment (Fund 164) to **MICROGENESIS SOFTWARE, INC.**


