**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB)
AND RECOMMENDING AWARD FOR THE REPAIR AND RENOVATION OF VARIOUS BUILDINGS
(RENOVATION OF BLDG. E (ROOFING, WINDOWS AND CEILING) AND RENOVATION
OF ACCOUNTING AND CASHIER'S OFFICE, ROOM F6, GUIDANCE COUNSELING ROOM,
INSTALLATION OF HOSTEL GUARD POST & DRIVEWAY STEEL RAMP, AND RENOVATION
OF STUDENT ACTIVITY CENTER AS PUBLICATION & SR OFFICE)

WHEREAS, The Iloilo Science and Technology University-Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Repair and Renovation of Various Buildings** (*Renovation of Bldg. E (Roofing, Windows and Ceiling) and Renovation of Accounting and Cashier's Office, Room F6, Guidance Counseling Room, Installation of Hostel Guard Post & Driveway Steel Ramp, and Renovation of Student Activity Center as Publication & SR Office*) on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with a total Approved Budget for the Contract (ABC) of Three Million Nine Hundred Ninety Five Thousand Seven Hundred Twenty Two Pesos (Php 3,995,722.00) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on October 18, 2023, with four (4) prospective bidders in attendance, namely;

1. Q.M Florete Construction
2. Urbancon Builder and Supply
3. CDJ Builders Corp.
4. A Maquiling Construction and Supply

WHEREAS, in response to the said posting, there were three (3) prospective bidders purchased the bidding documents, namely;

1. A Maquiling Construction and Supply
2. Skab Dragon Construction Services Co
3. Quatro Amigos Builders & Supply

WHEREAS, there were three (3) prospective bidders who submitted their bid proposals within the deadline set on November 7, 2023 at 5pm;

1. A Maquiling Construction and Supply
2. Skab Dragon Construction Services Co
3. Quatro Amigos Builders & Supply

WHEREAS, during the bid opening held last November 8, 2023, the BAC reviewed the eligibility, technical and financial envelops of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

2. Quatro Amigos Builders & Supply	Failed (incomplete financial documents)
3. Skab Dragon Construction Services Co	Failed (incomplete financial documents)



WHEREAS, all bidders who failed to comply the criteria ~~did not~~ ^{signified} their intention to file motion for reconsideration under Section 55 of the Revised IRR of RA 9184;

WHEREAS, the TWG conducted thorough review of bid, with the result:

WHEREAS, the BAC has conducted post-qualification to A Maquilng Construction and Supply last October 16, 2023 for the project similar to this project and determined that the bidder concerned has complied with and is responsive on all the requirements and conditions as specified in the Bidding Documents;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISATU Miagao Campus Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:

- To declare that **A MAQUILING CONSTRUCTION AND SUPPLY**, as the **Single Calculated and Responsive Bid (SCRB)** for the **Repair and Renovation of Various Buildings** (*Renovation of Bldg. E (Roofing, Windows and Ceiling) and Renovation of Accounting and Cashier's Office, Room F6, Guidance Counseling Room, Installation of Hostel Guard Post & Driveway Steel Ramp, and Renovation of Student Activity Center as Publication & SR Office*) and awarded the contract in the total amount of **Three Million Five Hundred Forty Three Thousand Six Hundred Eighty Seven Pesos and Forty Seven Centavos Only (Php 3,543,687.47)** inclusive of applicable taxes; and
