A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF JANITORIAL SUPPLIES (FUND 101) - EPA Project Reference No. MC-GOODS-2024-01-02

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Procurement of Janitorial Supplies (Fund 101)** – EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The Approved Budget for the Contract (ABC) of Six Hundred Thousand One Hundred Eighteen Pesos and Fifty Centavos Only (Php 600,118.50) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on **December 6, 2023**, with two (2) prospective bidders in attendance, namely;

- 1. Venson's Marketing
- 2. Armix Copier Rentals, Services and Sales

WHEREAS, in response to the said posting, there were four (4) prospective bidders purchased the bidding documents, namely;

- 1. Armix Copier Rentals, Services and Sales
- 2. ELM Industrial Sales
- 3. Games Bond Computer Shop and School Office Supplies Company
- 4. Venson's Marketing

WHEREAS, there were three (3) prospective bidders who submitted their bid proposals within the deadline set on **December 19, 2023** at 5pm;

- 1. Venson's Marketing
- 2. Armix Copier Rentals, Services and Sales
- 3. ELM Industrial Sales

WHEREAS, during the bid opening held last December 20, 2023, the BAC reviewed the eligibility, technical and financial envelops of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following result;
