A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS CONSTRUCTION, ELECTRICAL, AND PLUMBING/SANITARY SUPPLIES AND MATERIALS
