A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD FOR THE REPAIR OF HOSTEL PLUMBING AND SANITARY SYSTEM

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Repair of Hostel Plumbing and Sanitary System** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of **Eight Hundred Ninety Nine Thousand Four Hundred Twenty Five Pesos (Php 899,425.00)** inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on **February 13, 2024**, with only one (1) prospective bidder in attendance, namely;

WHEREAS, in response to the said posting, one (1) prospective bidder purchased the bidding documents, and submitted their proposal within the deadline set on February 26, 2027 at 5:00pm, namely;

1. Chedmary Const. & Supplies

WHEREAS, during the bid opening held last **February 27, 2024**, the BAC reviewed the eligibility, technical, and financial envelop of the said prospective bidder using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following result;
