A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF ELECTRO-PNEUMATIC TRAINER

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Electro-Pneumatic Trainer on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Seven Hundred Forty Thousand Pesos (Php 740,000.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on **February 13, 2024**, with only one (1) prospective bidder in attendance, namely;

1. Shoketsu SMC Corporation

WHEREAS, in response to the said posting, one (1) prospective bidder purchased the bidding documents, and submitted their proposal within the deadline set on February 26, 2027 at 5:00pm, namely;

1. Red Gutz Trading

WHEREAS, during the bid opening held last February 27, 2024, the BAC reviewed the eligibility, technical, and financial envelop of the said prospective bidder using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following result;
