A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF JANITORIAL SUPPLIES (FUND 164)

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Procurement of Janitorial Supplies (Fund 164)** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of **Three Hundred Twenty Three Thousand Eight Hundred Ninety Four Pesos (Php 323,894.00)** inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on **March 6, 2024**, with three (3) prospective bidders in attendance, namely;

WHEREAS, in response to the said posting, five (5) prospective bidders purchased the bidding documents, namely;

4. ELM Industrial Sales
5. Games Bond Computer Shop and School Office Supplies

WHEREAS, there were four (4) prospective bidders who submitted their bid proposal within the deadline set on **March 19, 2024** at 5pm, namely;

2. ELM Industrial Sales
3. Armix Copier Rentals Services and Sales
4. Games Bond Computer Shop and School Office Supplies
