A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PRINTING OF VARIOUS FORMS FOR REGISTRAR'S OFFICE

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Printing of Various Forms for Registrar's Office on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Five Hundred Forty Eight Thousand Two Hundred Pesos (Php 548,200.00) inclusive of applicable taxes;

WHEREAS, there were six (6) prospective bidders who submitted their bid proposal within the deadline set on March 25, 2024 at 5:00pm, namely;
