

CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of MAY 23 2024, between the **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY (ISAT U) - MIAGAO CAMPUS**, a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Brgy, Igtuba, Miagao, Iloilo, Philippines, represented herein by **DR. RAMON N. EMMANUEL, JR.**, in his capacity as Campus Administrator (hereinafter called the “**ISAT U**”) and **NO BOUNDARIES ADVERTISING AND EVENTS** with office address at Brgy. Pandac, Pavia, Iloilo, Philippines represented by its Owner, **MR. RHODERICK M. TECSON** (hereinafter referred to as the “**SUPPLIER**”);

WHEREAS, **ISAT U** invited Bids for certain goods and ancillary services, particularly the **PRINTING OF VARIOUS FORMS FOR REGISTRAR’S OFFICE** with Project Reference No. MC-GOODS-2024-03-10 and has accepted a Bid by the **NO BOUNDARIES ADVERTISING AND EVENTS** in the sum of **TWO HUNDRED NINETY FIVE THOUSAND SIX HUNDRED SIXTY FOUR PESOS & FOUR CENTAVOS ONLY (Php 295,664.04)**, hereinafter called the “Contract Price”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

3. In consideration for the sum of **TWO HUNDRED NINETY FIVE THOUSAND SIX HUNDRED SIXTY FOUR PESOS & FOUR CENTAVOS ONLY (Php 295,664.04)** or such other sums as may be ascertained, **NO BOUNDARIES ADVERTISING AND EVENTS** agrees to **SUPPLY VARIOUS FORMS** in accordance with his/her/its Bid.
4. The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY (ISAT U) - MIAGAO CAMPUS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
