A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF ICT SUPPLIES AND EQUIPMENT FOR DIFFERENT DEPARTMENT

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Procurement of ICT Supplies and Equipment for Different Department** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The Approved Budget for the Contract (ABC) of **Two Million Eighteen Thousand Eight Hundred Two Pesos Only (Php 2,018,802.00)** inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on **June 14, 2024**, with six (6) prospective bidders in attendance, namely;

2. AEP Systems Integration Inc.

4. Oxord Computer Solutions & Repair Center
5. Masangkay Computer Center
6. Armix Copier Rentals, Services and Sales

WHEREAS, there were four (4) prospective bidders who purchased the bidding documents and submitted their bid proposals within the deadline set on **June 26, 2024** at 5pm, namely;

1. Mircogenesis Software, Inc.
2. Oxord Computer Solutions & Repair Center
3. Armix Copier Rentals, Services and Sales
4. AEP Systems Integration Inc.

WHEREAS, during the bid opening held last **June 27, 2024**, the BAC reviewed the eligibility, technical and financial envelops of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following result:
