

CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of AUG 13 2024, between the **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY (ISAT U) - MIAGAO CAMPUS**, a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Brgy, Igtuba, Miagao, Iloilo, Philippines, represented herein by **DR. GABRIEL M. SALISTRE JR.**, in his capacity as SUC President III (hereinafter called the “**ISAT U**”) and **OXORD COMPUTER SOLUTIONS & REPAIR CENTER** with office address at Arnaldo Boulevard, Roxas City, Capiz, Philippines represented by its Owner, **MS. ROSELYN D. DOLFO** (hereinafter referred to as the “**SUPPLIER**”);

WHEREAS, **ISAT U** invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF ICT SUPPLIES AND EQUIPMENT FOR DIFFERENT DEPARTMENT** with Project Reference No. MC-GOODS-2024-06-13 and has accepted a Bid by the **OXORD COMPUTER SOLUTIONS & REPAIR CENTER** in the sum of **ONE MILLION FOUR HUNDRED THIRTY FIVE THOUSAND FOUR HUNDRED TWENTY THREE PESOS (Php 1,435,423.00)**, hereinafter called the “Contract Price”.



4. The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY (ISAT U) - MIAGAO CAMPUS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
