A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS FURNITURE FOR ADMIN. DEPARTMENT

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Procurement of Various Furniture for Admin. Department** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The Approved Budget for the Contract (ABC) of **One Million Six Hundred Seventy Three Thousand Five Hundred Forty Pesos Only (Php 1,673,540.00)** inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on **August 6, 2024**, with one (1) prospective bidders in attendance, namely;

WHEREAS, during the scheduled date for selling the Bid Documents on August 8-16, 2024, one (1) interested bidder availed the official bidding documents in the amount of Five Thousand Pesos Only (PhP 5,000.00), namely;


