**A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE
BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF JANITORIAL
SUPPLIES (FUND 101)**

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Procurement of Janitorial Supplies (Fund 101)** on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The Approved Budget for the Contract (ABC) of **Two Hundred Seventy Two Thousand Five Hundred Forty Five Pesos Only (Php 272,545.00)** inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on **September 20, 2024**, with one (1) prospective bidder in attendance, namely;

1. Charles Office and School Supplies

WHEREAS, during the scheduled date for selling the Bid Documents on September 24, 2024 to October 2, 2024, four (4) interested bidders availed the bidding documents in the amount of Five Hundred Pesos Only (Php 500.00), namely;

1. Charles Office and School Supplies
2. New Iloilo Izeem Commercial Summit, Inc.
3. ELM Industrial Sales
4. Games Bond Computer Shop and School Office Supplies Company

WHEREAS, three (3) prospective bidders submitted their bid proposals within the deadline set on **October 3, 2024** at 5pm, namely;

1. ELM Industrial Sales
2. New Iloilo Izeem Commercial Summit, Inc.
3. Games Bond Computer Shop and School Office Supplies Company

WHEREAS, during the bid opening held last **October 4, 2024**, the BAC reviewed the eligibility, technical and financial envelopes of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following result:
