WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Electronics Laboratory Equipment – EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Five Hundred Eighty Seven Thousand Pesos Only (Php 587,000.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on December 12, 2024, with one (1) prospective bidders in attendance, namely;

WHEREAS, during the scheduled date for selling the Bid Documents on December 13 – 24, 2024, one (1) interested bidder availed the bidding documents in the amount of One Thousand Pesos Only (Php 1,000.00), namely;




