A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO AEP SYSTEMS INTEGRATION INC. FOR THE PROCUREMENT OF ICT SUPPLIES AND DEVICES (FUND 101) – EPA

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of ICT Supplies and Devices (Fund 101) – EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of One Million Five Hundred Forty Six Thousand One Hundred Seventy Eight Pesos Only (Php 1,546,178.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on November 26, 2024, with two (2) prospective bidders in attendance, namely;

- 1. Armix Copier Rentals, Services and Sales
- 2. Microgenesis Software, Inc.

WHEREAS, during the scheduled date for selling the Bid Documents on November 27, 2024 to December 6, 2024, three (3) interested bidders availed the bidding documents in the amount of Five Thousand Pesos Only (Php 5,000.00), namely;

- 1. Armix Copier Rentals, Services and Sales
- 2. New Iloilo Izeem Commercial Summit Inc.
- 3. AEP Systems Integration Inc.

WHEREAS, three (3) bidders submitted a bid proposal within the deadline set on December 9, 2024 at 5pm, namely;

- 1. New Iloilo Izeem Commercial Summit Inc.
- 2. Armix Copier Rentals, Services and Sales
- 3. AEP Systems Integration Inc.

WHEREAS, during the bid opening held last December 10, 2024, the BAC reviewed the eligibility, technical and financial envelops of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:

To declare that AEP SYSTEMS INTEGRATION INC. as the Lowest Calculated and Responsive Bid (LCRB) for the PROCUREMENT OF ICT SUPPLIES AND DEVICES (FUND 101) EPA and awarded the contract in the total amount of One Million Three Hundred Ninety Five Thousand One Hundred Ninety Two Pesos Only (Php 1,395,192.00) inclusive of applicable taxes; and
