**A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO NEW ILOILO IZEEM COMMERCIAL SUMMIT INC. FOR THE PROCUREMENT OF JANITORIAL SUPPLIES (FUND 101) – EPA**

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Janitorial Supplies (Fund 101) – EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Six Hundred Ninety One Thousand Six Hundred Eleven Pesos & Fifty Centavos Only (Php 691,611.50) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on November 26, 2024, with two (2) prospective bidders in attendance, namely;

1. ROG Enterprise
2. Armix Copier Rentals, Services and Sales

WHEREAS, during the scheduled date for selling the Bid Documents on November 27, 2024 to December 6, 2024, three (3) interested bidders availed the bidding documents in the amount of One Thousand Pesos Only (Php 1,000.00), namely;

1. ELM Industrial Sales
2. ROG Enterprise
3. New Iloilo Izeem Commercial Summit Inc.

WHEREAS, three (3) bidders submitted a bid proposal within the deadline set on December 9, 2024 at 5pm, namely;

1. ROG Enterprise
2. New Iloilo Izeem Commercial Summit Inc.
3. ELM Industrial Sales

WHEREAS, during the bid opening held last December 10, 2024, the BAC reviewed the eligibility, technical and financial envelops of the prospective bidders using the “pass/fail” criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:
