WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of State-of-the-Art Cosmetology Equipment – EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Two Hundred Twenty Three Thousand Pesos Only (Php 223,000.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on November 26, 2024, with one (1) prospective bidders in attendance, namely;

WHEREAS, during the scheduled date for selling the Bid Documents on November 27, 2024 to December 6, 2024, one (1) interested bidder availed the bidding documents in the amount of Five Hundred Pesos Only (Php 500.00), namely;
