RESOLUTION NO. 009, s. 2025

**A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB)
AND RECOMMENDING AWARD TO SIBALOM GLASS ALUMINUM CONSTRUCTION SUPPLY
AND SERVICES FOR THE CONSTRUCTION AND REPAIR OF VARIOUS BUILDINGS
Project Reference No. ISAT U MC-INFRA-2024-10-20**

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Construction and Repair of Various Buildings on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of One Million Three Hundred Twenty Two Thousand Seven Hundred Sixty Eight Pesos Only (Php 1,322,768.00) inclusive of applicable taxes;

WHEREAS, the Bids and Awards Committee (BAC) declared the first bidding as FAILED under BAC Resolution No. 019, dated November 25, 2024;

WHEREAS, on December 12, 2024, the Bids and Awards Committee (BAC) posted the 2nd Invitation to Bid for the Construction and Repair of Various Buildings the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University in accordance with Section 21.2 of the IRR of RA 9184;

WHEREAS, a Pre-Bid Conference was held on December 12, 2024, with four (4) prospective bidders in attendance, namely;

1. Makenzi Construction and Supply
2. Sibalom Glass Aluminum Construction Supply and Services
3. Giantwest Construction Corp.
4. A Maquiling Construction and Supply

WHEREAS, during the scheduled date for selling the Bid Documents on December 13 – 24, 2024, three (3) interested bidders availed the official bidding documents in the amount of Five Thousand Pesos Only (Php 5,000.00), namely;

1. Sibalom Glass Aluminum Construction Supply and Services
2. Makenzi Construction and Supply
3. A Maquiling Construction and Supply

WHEREAS, three (3) bidders submitted a bid proposal within the deadline set on December 26, 2024 at 5pm, namely;

1. Sibalom Glass Aluminum Construction Supply and Services
2. A Maquiling Construction and Supply
3. Makenzi Construction and Supply

WHEREAS, during the bid opening held last December 27, 2024, the BAC reviewed the eligibility, technical and financial envelopes of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:

WHEREAS, the TWG conducted thorough review of bid, with the following results:

WHEREAS, the BAC conducted post-qualification to Sibalom Glass Aluminum Construction Supply and Services for site visit and review of documents last January 17, 2025, and determined that the bidder concerned has complied with and is responsive on all the requirements and conditions as specified in the Bidding Documents and as provided under Section 34.4 of 2016 Revised Implementing Rules and Regulations of RA 9184;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISATU Miagao Campus Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:

- a. To declare that SIBALOM GLASS ALUMINUM CONSTRUCTION SUPPLY AND SERVICES as the Lowest Calculated and Responsive Bid (LCRB) for the Construction and Repair of Various Buildings and awarded the contract in the total amount of One Million One Hundred Sixty Seven Thousand One Hundred Ninety Six Pesos and Forty Five Centavos Only (Php 1,167,196.45) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
