A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO AEP SYSTEMS INTEGRATION INC. FOR THE PROCUREMENT OF ICT EQUIPMENT FOR VARIOUS DEPARTMENT – EPA

Project Reference No. ISAT U MC-GOODS-2025-01-03

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of ICT Equipment for Various Department – EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Five Hundred Thousand Pesos Only (Php 500,000.00) inclusive of applicable taxes;

WHEREAS, THE Bids and Awards Committee (BAC) declared the first bidding as FAILED under BAC Resolution No. 020, dated December 20, 2024;

WHEREAS, on February 5, 2025, the Bids and Awards Committee (BAC) posted the 2nd Invitation to Bid for the Procurement of ICT Equipment for Various Department – EPA the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University in accordance with Section 21.2 of the IRR of RA 9184;

WHEREAS, a Pre-Bid Conference was held on February 13, 2025, with four (4) prospective bidders in attendance, namely;

1. AEP System Integration Inc.
2. Armix Copier Rentals, Services and Sales
3. Computron Business Center
4. Microgenesis Software, Inc.

WHEREAS, during the scheduled date for selling the Bid Documents on February 17, 2025 to February 25, 2025, two (2) interested bidders availed the bidding documents in the amount of Five Hundred Pesos Only (Php 500.00), namely;

1. AEP Systems Integration Inc.
2. Armix Copier Rentals, Services and Sales

WHEREAS, two (2) bidders submitted a bid proposal within the deadline set on February 26, 2025 at 5pm, namely;

1. AEP Systems Integration Inc.
2. Armix Copier Rentals, Services and Sales

WHEREAS, during the bid opening held last February 27, 2025, the BAC reviewed the eligibility, technical and financial envelopes of the prospective bidders using the “pass/fail” criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:

WHEREAS, the BAC conducted post-qualification to AEP Systems Integration Inc. through a site visit last January 7, 2025, and MORE Electric and Power Corporation as their Single Largest Completed Contract (SLCC) last March 7-13, 2025, and determined that the bidder concerned has complied with and is responsive on all the requirements and conditions as specified in the Bidding Documents and as provided under Section 34.4 of 2016 Revised Implementing Rules and Regulations of RA 9184;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISATU Miagao Campus Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:

- To declare that AEP SYSTEMS INTEGRATION INC. as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF EQUIPMENT FOR VARIOUS DEPARTMENT – EPA and awarded the contract in the total amount of Four Hundred Sixty Eight Thousand Eight Hundred Pesos Only (Php 468,800.00) inclusive of applicable taxes; and
- To recommend for approval of the Campus Administrator the foregoing findings.


