A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO MICROGENESIS SOFTWARE, INC. FOR THE PROCUREMENT OF ICT SUPPLIES AND EQUIPMENT FOR COMPUTER STUDIES

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement Of ICT Supplies and Equipment for Computer Studies on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Two Million Eight Hundred Nine Thousand Four Hundred Sixty Pesos Only (Php 2,809,460.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on March 27, 2025, with three (3) prospective bidders in attendance, namely;

- 1. Microgenesis Software, Inc.
- 2. Armix Copier Rentals Services and Sales
- 3. AEP Systems Integration Inc.

WHEREAS, during the scheduled date for selling the Bid Documents on March 28, 2025 to April 7, 2025, three (3) interested bidders availed the bidding documents in the amount of Five Thousand Pesos Only (Php 5,000.00), namely;

- 2. Microgenesis Software, Inc.
- 3. AEP Systems Integration Inc.

WHEREAS, three (3) bidders submitted a bid proposal within the deadline set on April 8, 2025 at 5pm, namely;
