A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO NEW ILOILO IZEEM COMMERCIAL SUMMIT INC. FOR THE PROCUREMENT OF COMMON-USE SUPPLIES, ICT SUPPLIES AND EQUIPMENT (FUND 163)

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Common-Use Supplies, ICT Supplies and Equipment (Fund 163) on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Two Hundred Eighty Three Thousand Four Hundred Fifty Three Pesos & Fifty Centavos Only (Php 283,453.50) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on April 24, 2025, with only one (1) prospective bidder in attendance, namely;

1. Charles Office and School Supplies

WHEREAS, during the scheduled date for selling the Bid Documents on April 28, 2025 to May 6, 2025, only one (1) interested bidder availed the bidding documents in the amount of Five Hundred Pesos Only (Php 500.00), namely;

New Iloilo Izeem Commercial Summit Inc.

WHEREAS, only one (1) bidder submitted a bid proposal within the deadline set on May 7, 2025 at 5pm, namely;

1. New Iloilo Izeem Commercial Summit Inc.

WHEREAS, during the bid opening held last May 8, 2025, the BAC reviewed the eligibility, technical and financial envelops of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:
