A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO NEW ILOILO IZEEM COMMERCIAL SUMMIT INC. FOR THE PROCUREMENT OF JANITORIAL SUPPLIES (FUND 164)

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Janitorial Supplies (Fund 164) on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Three Hundred Three Thousand Five Hundred Ninety One Pesos Only (Php 303,591.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on March 27, 2025, with two (2) prospective bidders in attendance, namely;

- 1. FM's Office Supplies and Equipment Trading
- 2. Charles Office and School Supplies

WHEREAS, during the scheduled date for selling the Bid Documents on March 28, 2025 to April 7, 2025, two (2) interested bidders availed the bidding documents in the amount of Five Hundred Pesos Only (Php 500.00), namely;

- 1. New Iloilo Izeem Commercial Summit Inc.
- 2. Charles Office and School Supplies

WHEREAS, two (2) bidders submitted a bid proposal within the deadline set on April 8, 2025 at 5pm, namely;

WHEREAS, during the bid opening held last April 10, 2025, the BAC reviewed the eligibility, technical and financial envelops of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:
