A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PROGRESS HOME & OFFICE FURNISHINGS FOR THE PROCUREMENT OF VARIOUS FURNITURE FOR DIFFERENT OFFICES AND DEPARTMENT

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Various Furniture for Different Offices and Department on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of One Million Ninety Three Thousand One Hundred Ninety Five Pesos Only (Php 1,093,195.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on April 24, 2025, with three (3) prospective bidders in attendance, namely;

- 1. Progress Home & Office Furnishings
- 2. Filcrafters, Inc.
- 3. LBPI Design International Inc.

WHEREAS, during the scheduled date for selling the Bid Documents on April 28, 2025 to May 6, 2025, only one (1) interested bidder availed the bidding documents in the amount of Five Thousand Pesos Only (Php 5,000.00), namely;

1. Progress Home & Office Furnishings

WHEREAS, only one (1) bidder submitted a bid proposal within the deadline set on May 7, 2025 at 5pm, namely;

1. Progress Home & Office Furnishings

WHEREAS, during the bid opening held last May 8, 2025, the BAC reviewed the eligibility, technical and financial envelops of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:
