A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO A MAQUILING CONSTRUCTION AND SUPPLY FOR THE IMPROVEMENT OF COVERED COURT

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Improvement of Covered Court on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Nine Hundred Ninety Eight Thousand Three Hundred Nine Pesos Only (Php 998,309.00) inclusive of applicable taxes:

WHEREAS, a Pre-Bid Conference was held on April 3, 2025, with three (3) prospective bidders in attendance, namely;

- 1. Makenzi Construction and Supply
- 2. A Maquiling Construction and Supply
- 3. Abelarde Builders & Supply

WHEREAS, during the scheduled date for selling the Bid Documents on April 4, 2025 to April 14, 2025, only one (1) interested bidder availed the bidding documents in the amount of One Thousand Pesos Only (Php 1,000.00), namely;

1. A Maquiling Construction and Supply

WHEREAS, only one (1) bidder submitted a bid proposal within the deadline set on April 15, 2025 at 5pm, namely;

1. A Maquiling Construction and Supply

WHEREAS, during the bid opening held last April 16, 2025, the BAC reviewed the eligibility, technical and financial envelops of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:

To declare that A MAQUILING CONSTRUCTION AND SUPPLY as the Single Calculated and Responsive Bid (SCRB) for the IMPROVEMENT OF COVERED COURT and awarded the contract in the total amount of Nine Hundred Six Thousand Two Hundred Twenty Six Pesos and Twenty Five Centavos Only (Php 906,226.25) inclusive of applicable taxes; and
