A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO GEMS ELECTRONICS FOR THE PROCUREMENT OF ELECTRICAL INSTRUCTIONAL SUPPLIES AND MATERIALS

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Electrical Instructional Supplies and Materials on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Two Hundred Twelve Thousand Three Hundred Forty Pesos Only (Php 212,340.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on June 10, 2025, with only one (1) prospective bidder in attendance, namely;

1. Gems Electronics

WHEREAS, during the scheduled date for selling the Bid Documents on June 11, 2025 to June 23, 2025, only one (1) interested bidder availed the official bidding documents in the amount of Five Hundred Pesos Only (Php 500.00), namely;

WHEREAS, only one (1) bidder submitted a bid proposal within the deadline set on June 24, 2025 at 5pm, namely;

WHEREAS, during the bid opening held last June 25, 2025, the BAC reviewed the eligibility, technical and financial envelops of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:



To declare that GEMS ELECTRONICS as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF ELECTRICAL INSTRUCTIONAL SUPPLIES AND MATERIALS and to award the contract in the total amount of Two Hundred Seven Thousand Six Hundred Sixty Nine Pesos Only (Php 207,669.00) inclusive of applicable taxes; and
