**A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE
BID (SCRB) AND RECOMMENDING AWARD TO BC ENTERPRISES
FOR THE PROCUREMENT OF KITCHENWARE AND TOOLS FOR LABORATORY USE**

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Kitchenware and Tools for Laboratory Use on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Eight Hundred Sixteen Thousand One Hundred Eighty Five Pesos Only (Php 816,185.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on July 11, 2025, with two (2) prospective bidders in attendance, namely;

1. ELM Industrial Sales
2. BC Enterprises

WHEREAS, during the scheduled date for selling the Bid Documents from July 14, 2025 to July 22, 2025, only one (1) interested bidder availed the official bidding documents in the amount of One Thousand Pesos Only (Php 1,000.00), namely;

1. BC Enterprises

WHEREAS, only one (1) bidder submitted a bid proposal within the deadline set on July 23, 2025 at 5pm, namely;

1. BC Enterprises

WHEREAS, during the bid opening held last July 30, 2025, the BAC reviewed the eligibility, technical and financial envelopes of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:

To declare that BC ENTERPRISES as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF KITCHENWARE AND TOOLS FOR LABORATORY USE and to award the contract in the total amount of Eight Hundred Seven Thousand Nine Hundred Sixty Three Pesos and Fifty Centavos Only (Php 807,963.50) inclusive of applicable taxes; and
- b. To recommend for approval of the Campus Administrator the foregoing findings.
