A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO AEP SYSTEMS INTEGRATION INC. FOR THE PROCUREMENT OF ICT SUPPLIES AND EQUIPMENT FOR DIFFERENT OFFICES AND DEPARTMENT

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of ICT Supplies and Equipment for Different Offices and Department on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Two Million Nine Hundred Eighty Thousand Ninety Pesos Only (Php 2,980,090.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on July 11, 2025, with four (4) prospective bidders in attendance, namely;

1. Microgenesis Software, Inc.
2. Masangkay Computer Center
3. Armix Copier Rentals, Services and Sales
4. AEP Systems Integration Inc.

WHEREAS, during the scheduled date for selling the Bid Documents from July 14, 2025 to July 22, 2025, only one (1) interested bidder availed the official bidding documents in the amount of Five Thousand Pesos Only (Php 5,000.00), namely;

1. AEP Systems Integration Inc.

WHEREAS, only one (1) bidder submitted a bid proposal within the deadline set on July 23, 2025 at 5pm, namely;

1. AEP Systems Integration Inc.

WHEREAS, during the bid opening held last July 30, 2025, the BAC reviewed the eligibility, technical and financial envelopes of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:

- a. To declare that AEP SYSTEMS INTEGRATION INC. as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF ICT SUPPLIES AND EQUIPMENT FOR DIFFERENT OFFICES AND DEPARTMENT and to award the contract in the total amount of Two Million Nine Hundred Seventy Nine Thousand One Hundred Thirty Pesos and Fifty Six Centavos Only (Php 2,979,130.56) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.


