A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO NEW ILOILO IZEEM COMMERCIAL SUMMIT INC. FOR THE PROCUREMENT OF OFFICE AND JANITORIAL SUPPLIES (FUND 101)

WHEREAS, The Iloilo Science and Technology University - Miagao Campus, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Office and Janitorial Supplies (Fund 101) on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Miagao Campus Website, BAC Facebook Page, and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the Approved Budget for the Contract (ABC) of Three Hundred Thirty Five Thousand Four Hundred Twenty One Pesos Only (Php 335,421.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on July 11, 2025, with two (2) prospective bidders in attendance, namely;

- 1. Armix Copier Rentals Services and Sales
- 2. Apstar Trader & Printer

WHEREAS, during the scheduled date for selling the Bid Documents from July 14, 2025 to July 22, 2025, four (4) interested bidder availed the official bidding documents in the amount of Five Hundred Pesos Only (Php 500.00), namely;

- 1. Apstar Trader & Printer
- 2. New Iloilo Izeem Commercial Summit Inc.
- 3. ROG Enterprise
- 4. Armix Copier Rentals Services and Sales

WHEREAS, four (4) bidders submitted a bid proposal within the deadline set on July 23, 2025 at 5pm, namely;

- 1. Apstar Trader & Printer
- 2. Armix Copier Rentals Services and Sales
- 3. ROG Enterprise
- 4. New Iloilo Izeem Commercial Summit Inc.

WHEREAS, during the bid opening held last July 30, 2025, the BAC reviewed the eligibility, technical and financial envelops of the prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:

To declare that NEW ILOILO IZEEM COMMERCIAL SUMMIT INC. as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF OFFICE AND JANITORIAL SUPPLIES and to award the contract in the total amount of Two Hundred Twenty Two Thousand Two Hundred Fourteen Pesos and Fifty Centavos Only (Php 222,214.50) inclusive of applicable taxes; and
